

FREMONT COUNTY FAIR & RODEO ROYALTY CONTEST RULES  
FOR AUGUST 28, 2010

**ELIGIBILITY:** Each queen contestant must not be less than 18 years of age or more than 23 years of age as of December 31, 2010. Each Jr. Queen contestant must not be less than 15 years of age or more than 17 years of age as of December 31, 2010. Each Princess contestant must not be less than 12 years of age or more than 14 years of age as of December 31, 2010. Ambassador contestants must not be less than 12 years of age or more than 23 years of age as of December 31, 2010. Contestants shall never have been married or had children, not currently cohabitating, shall waive liability and be a legal resident of Fremont County. There will be a contestant fee of \$16.00, which includes the dinner, payable to the Fremont County Friends of Fair.

**ENTRY:** Entry deadline is August 24, 2010.

**JUDGING:** Contestants will be judged on (1) Appearance; (2) Personality; (3) Horsemanship; (4) Two to Three Minute Speech; (5) A Written Test On County Fair and Rodeo; (6) Modeling; (7) Interview and (8) Impromptu Questions. The Judges will seek Sincerity, Integrity, Attractiveness, High Moral Standards, and Maturity.

**RESPONSIBILITIES OF QUEEN, JR. QUEEN, PRINCESS AND AMBASSADOR:** The Queen, first attendant, Jr. Queen, Princess and Ambassador shall help hand out Fremont Co. Fair ribbons and trophies at the Fremont Co. Fair & Rodeo Horse Days July 29 & 30, 2011 and the Fremont Co. Fair & Rodeo July 27 to August 6, 2010. The Fremont Co. Fair and Rodeo Queen Committee, the Queen, first attendant, Jr. Queen, Princess, and Ambassador and the Fremont Co. Fair Manager will determine the schedule. The Queen, first attendant, Jr. Queen, Princess and Ambassador will make two radio appearances prior to the fair, which will promote the Fremont Co. Fair. They will also represent the Fremont Co. Fair & Rodeo at the two Fremont Co. Fair rodeos and the Fremont Co. Fair Parade.

**ELIGIBILITY FOR MISS RODEO WYOMING CONTEST:** The Fremont County Fair Queen is eligible to compete for the title of Miss Rodeo Wyoming at the State Fair Contest in August 2011. It shall be the responsibility of the Fremont Co. Fair Queen to pay the \$125.00 contestant fee to the Miss Rodeo Wyoming Organization. It shall also be the responsibility of the Fremont Co. Fair & Rodeo Queen to provide the "Miss Rodeo Wyoming" committee with any photos requested by the Miss Rodeo Wyoming Organization.

**Contest Date:** The contest will be August 28, 2010 beginning at 10:00 A.M. contingent upon having at least 3 entries in the Queen contest. The Jr. Queen, Princess and Ambassador contest will be held only if the queen contest is held and there are three entries in each category. If the contest is cancelled the entry fees will be refunded. The contest will begin at 10:00 A.M. at the Fremont County Fair & Rodeo Arena and the interviews will begin at 2:00 P.M. at the Fremont County Fair Armory with dinner for contestants and guests to follow at 5:30 P.M. Schedule is subject to changes.
